Minutes of a Meeting of Great Ayton Parish Council

held on Tuesday 1st August 2000 at 7.00 pm

Present

Councillors Mrs J Imeson, Chairman, J Fletcher, R Kirk, P Bell, L Groves, Mrs F Greenwell, Mrs M Stevens. Mrs Carole Freemnan and two members of the public also attended.

Presentation of gift to Mrs Freeman

The Parish Council presented Mrs Freeman with a copy of the Great Ayton Millennium Book in recognition of the many years she had attended and reported on their meetings. Mrs Freeman expressed her thanks.

Minutes

The minutes of the meeting held on Tuesday 4th July 2000 were approved and signed.

Police Business

There was no police representation and no matters were raised.

Matters arising

High Green bylaws etc Response awaited from Chief Constable

<u>Ayton School Development/lease for sports field</u> The lease had been completed. Water and electricity would be laid on in the pavilion, the keys for which would be accepted on completion of the work. A committee for the junior football and cricket club had been formed. A Parish Councillor would be on the committee but would attend meetings only when asked. Councillor Mrs Greenwell proposed Councillor Mrs Imeson, seconded by Councillor Mrs Stevens. All agreed.

<u>Play area - plan for improvement</u> The play area sub-committee had resolved, after much discussion and in the interests of safety, to open up the play area by removal of the hedge and installation of a low metal fence. Following the installation of the new play equipment, which had been bedevilled by the appalling behaviour of certain young children, representations had been made by neighbouring residents to maintain the hedge which would shield them from the worst of the noise and disturbance. The police had been required to attend on several occasions. Mrs Heaviside and Mrs Tanfield were invited by the Chairman to state their views on the situation. It was then pointed out that the new equipment was designed for children of 7 years and under and it was hoped that the novelty would wear off for the older children very quickly. In the meantime, the hedge would be maintained and a lockable security gate installed so that the play area could be locked each evening. The provision of vandal proof paint for the roofs of the towers would be investigated. B Helm would be asked to clip the hedge.

<u>Cemetery - overhanging trees</u> Minute continued. Tree near Yatton House on Guisborough Road also to be inspected.

<u>Hambleton District Wide Local Plan</u> Councillor Mrs Imeson had completed the consultation document. <u>Tourism advertisement</u> It was agreed that the photograph would be changed to one of Roseberry Topping.

Nuisance youths, Chapel steps NYCC had filled in the hole under the fence.

<u>Trees, river side near Stone Bridge</u> It was too big a job for the Cemetery Superintendent and a contractor would be asked to deal with them.

<u>River bed near Leven Court</u> The Environment Agency was not responsible for the river upstream of the waterfall.

Wimpey would be notified of the erosion to the buttresses of the new footbridge.

<u>Flower baskets/troughs</u> It was reported that the flowers had been pulled out of the troughs on the toilet wall and deposited in the toilets. Councillor Fletcher and his wife had rescued and replanted them. Mr Winn was to put up the two remaining baskets in the near future. It was agreed that they should go on the wall of the Village Hall and not the chemist's wall.

Councillors Reports

Councillor Fletcher reported that there was ragwort growing on Low Green, and grass growing between the road and paving stones on High Green. B Helm to deal with these matters. The footpath by the railway line near the bridge on Thief Lane was overgrown. Railtrack to be asked to cut back the vegetation.

Councillor Mrs Greenwell reported that the street cleaner had made a good job of cleaning the pavement. He was having difficulty with the beehive bins which were oblong but which had round bag holders causing rubbish to miss the bags. The possibility of replacing them with reconditioned wrought iron bins would be investigated.

Councillor Kirk suggested that when the playground alterations were complete there should be an official opening to which parents would be invited.

Councillor Mrs Stevens reported that a hedge near the fish shop was becoming an obstruction.

Councillor Mrs Imeson said that there was to be a Captain Cook Day in Great Ayton on 25.10.00. Children from the school would make boats to race on the river and guests would be invited to lunch followed by a service in All Saints Church. It was agreed that the Parish Council would pay for tea for guests in the church hall.

Brian Helm said that the cemetery extension would be needed in the not too distant future. Councillors Mrs Imeson and Mrs Stevens would visit the cemetery and see what should be done.
