## Minutes of a Meeting of Great Ayton Parish Council

# held on Tuesday 23<sup>rd</sup> July 2002 at 7.00 pm

#### **Present**

Councillors Mrs F Greenwell, Chairman, Mrs J Imeson, Mrs M Stevens, L Groves, P Bell, J Fletcher and R Kirk. Sgt M McLoughlin also attended.

#### Minutes

The minutes of the meeting held on Tuesday 25<sup>th</sup> June 2002 were approved and signed.

#### **Police Business**

Sgt McLoughlin reported that there had been 71 incidents so far in July, compared to 141 in June. Thefts were up from 5 to 8; complaints regarding conduct of youths were down from 33 to 11, with 20 and 5 respectively involving football on High Green. There were no house burglaries in June or July. Incidents of damage to property were 9 in June and 5 in July, and assaults 5 in June and 1 in July.

There was lengthy discussion regarding problems with antisocial behaviour and the Council was advised that Hambleton Community Safety Partnership had set up a working party to tackle the problem in Stokesley and the process had been started for Great Ayton. The suitability of the existing byelaws for dealing with problems on High Green was discussed. It was observed that the problem was not youths playing football but those who were using footballs as a weapon and deliberately causing havoc. Underage drinking also presented a problem and bootleg alcohol was partly to blame.

Councillors again reported difficulties of residents trying to telephone the police. Teething problems at the call centre were again blamed.

Sgt McLoughlin was thanked for attending the meeting in his own time.

#### Cemetery

Mr Atkinson reported no problems at the cemetery. An estimate had been received for the mechanical digging of double graves but was thought to be too high. The paths had been sprayed again.

The play area equipment which had been newly painted looked very smart. The seesaw wood had been replaced. Mr Atkinson had experienced some trouble with youngsters not wanting to leave when he went to lock the gate at closing time.

A complaint had been received from a resident about the uncut vegetation on the river bank below the stone bridge. Councillors agreed that the river bank looked nice in its natural state. Councillor Mrs Greenwell said that Japanese hogweed had been found growing there, which should not be touched. She had reported it to the Environment Agency.

Mr Atkinson had recently painted three of the village seats, completing the task started last year.

Dog fouling on Low Green had been considerably reduced. It was thought this was probably due to a resident being tackled about not cleaning up after her dogs. A person who allowed her two dogs to foul in Addison Road had been warned and was under surveillance.

## Matters arising

<u>Bus stop – Newton Road</u> No reply from NYCC. Councillor Mrs Greenwell had sketched the site and thought that it could be moved a few yards south without too much difficulty and this would alleviate the resident's problem. Councillor Fletcher would take the suggestion to NYCC.

<u>Public open space</u> Wimpey's technical department would consult with their legal department and it was hoped to conclude the matter speedily.

<u>Development of website for Great Ayton</u> Mr Kirby was engaged in correspondence with the holders of the website and was confident that everything would be sorted out in due course. It was agreed to conclude the minute for the time being.

<u>Village name plinth – Yarm Lane</u> HDC were not responsible for rebuilding the wall. It was agreed that NYCC be asked to rebuild it and charge any costs to the Parish Council.

Provision of dormer windows – Topcliffe House, Low Green. *The Council thought that the side elevation was extremely ugly and obtrusive* 

Provision of dormer windows as amended - Topcliffe House. As above

Construction of detached dwellinghouse and domestic treble garage to replace existing – minor amendments – Stanley Houses. *HDC would be asked why so much completely new build had been allowed in this case. There seemed to be a lack of consistency in applying policy to build in same footprint* 

Application for Listed Building Consent for the demolition and reconstruction of part of existing wall – Church of All Saints, Low Green. *No representations* 

Alterations and extensions to existing dwellinghouse – 5 Roseberry Ave. *No representations but HDC to be asked to make sure neighbours were aware* 

Alterations and two storey extension to existing dwellinghouse – 17 Roseberry Road. No representations

#### Annual accounts for audit

The accounts were accepted by the Parish Council and signed by the Chairman. The statement of assurance was approved by the Council.

Cllr Bell reported that there were 77 broken paving stones between 1 Linden Road and the junction with Addison Road. Cars were being parked on the triangle of grass outside 16 Linden Road. Mr Eardley had complained about the big hedge on Guisborough Road next to the allotments. All these matters would be reported to NYCC Highways.
