Footpath Easby Lane to Suggitts Field – Underground Leak

This is still not repaired and further complaints have been received – Cllr Moorhouse had raised this with the Highways Team who had advised that this was only a problem in exceptional circumstances. It was confirmed that this is not the case by those who regularly use the path but that it is a permanent problem. Cllr Moorhouse reported that a new structure was in place and that this was now with the new team for assessment. **Ongoing.**

Flooding on Easby Lane – Further flooding reported during the recent heavy rain. The collapsed drain was now repaired so the situation would be monitored to see if this resolved the flooding problem. **Ongoing.**

Footpath behind Cliffe Terrace – No change. – Advised that this was still on the future action list but was not seen as a priority.

The Clerk had requested that the disabled parking bay in Park Square paint be refreshed. Awaiting response. **Ongoing.**

Cllr Fletcher informed Members that he had attended a meeting at the NYMNPA where he had met with the Rt Hon Owen Patterson MP who was interested in the flood prevention scheme that had taken place in Great Ayton, he was also extremely impressed with the Apprenticeship work that had taken place in the relation to the slow the flow project. He was particularly impressed with the Community Focus stemming from the scheme and how the work had taken place had involved the community.

Cllr Fletcher sought agreement for a local Bed and Breakfast to advertise on the Parish Council website. This was agreed as we already have local business identified.

Cllr Fletcher advised Members that the Cemetery Superintendent and his Assistant were going to re-paint the Victorian Urinal and also that they were going to fill in some potholes around the High Green.

Cllr Mrs Brown raised a concern in relation to the state of the road at Park Rise it was agreed that the Clerk should request that this road and Romany Road be considered for future resurfacing.

Cllr Mrs Brown expressed concern at the state of Chapel Steps where pot holes had recently been filled in but were left raised and unsafe. Clerk to report to Highways.

Cllr Mrs Greenwell had received a number of complaints in relation to rats along the riverbank. The Clerk advised that Hambleton District Council had completed the work to dispose of the problem.
