# Minutes of the Meeting of the Parish Council of Great Ayton Parish Council held on Tuesday 4 October 2016 at 7.00 pm

1	Apologies for Absence Apologies for absence were received from Cllr G Readman, Cllr Mrs H Moorhouse and Mrs Calgie (D&S Reporter).
2	Declaration of Interest in items on the Agenda  Declarations declared and noted with the relevant topic/s.
3	Members of the Public invited to address Council Cleveland Lodge proposed development - representation was made to try an answer some of the question that had been raised at the Planning Committee meeting in regard to this development. Members confirmed that they remained opposed to this development as it was outside of the current Local Development Framework (LDF) requirements which were for a C2 class care development rather that this proposed C3 class development. It was also larger than agreed within the LDF. Noted.  Angrove Park proposed development - representation was made in regard to the new planning application for this development which was reduced in size following discussions with planning officers etc. The Planning Application would be considered at the next PC meeting as the plans had only just been received.
	A local business owner was also in attendance to offer support for this development stating that the Village relies on Tourists and this development would increase that. <b>Noted.</b>
4	Minutes of the Meeting of the Parish Council held on Tuesday 6 September 2016  The minutes of the Meeting of the Parish Council held on Tuesday 6 September 2016 were approved and signed subject to the following amendment. Paragraph 11 - the Business Forum would set up a formally constituted group and open a bank account, a sub group consisting of three representatives from the Business Forum and three from the Parish Council would oversee events such as the Christmas Event.  Agreed.
5	Police Report  PCSO Lewis presented the Police report and reported that a total of 14 incidents had been reported between and 5 September and 4 October 2016. A proposal to install CCTV Equipment in and around the Discovery Centre Car Park and the Arcade area would be discussed at the next Great Ayton Discovery Centre meeting. Noted.
6	Council Services Report Cemetery The Clerk had contacted the Vicar in regard to the consecration of the Cemetery land. The Vicar had confirmed that he would discuss this with the Bishop. Noted.

**Captain Cook Garden -** Cllr Fletcher was in discussions with Asham Bryant College to undertake further work within the garden in due course. **Noted.** 

**Public Conveniences** - it was reported that a new arm had been replace on the cistern, however, the Clerk reported that this was already broken and that this is why a new more robust cistern was required because the arm to the flushing system continues to get broken as it is just plastic. It was agreed that a full new cistern would be installed as soon as possible. It was also agreed to try and obtain a specification and costs for refurbishing the toilets so that members could consider whether to included this scheme in the budget next year as well as seeing if they could secure \$106 funds towards it. **Agreed.** 

**Play Park** - It was noted that work to the toddler area had commenced and was progressing well and had received a lot of positive comments. There was currently an issue with litter but it was noted that this was because of the absence of the Cemetery Superintendent who usually conducts a litter pick each day within the play park. An area that was currently just mud would be planted by Yatton House. **Noted.** 

Christmas Events - the Carols on the High Green would take place on Monday 19 December 2016 commencing at 7 pm, the Chairman has nominated the Great North Air Ambulance as the charity for the collection this year. The Santa Sleigh would go round the Village on Friday 23 December 2016. The Business forum have ordered a tree for the High Green and this will be erected in the week leading up to the Christmas Event on the High Green on 26 November 2016. The Clerk was asked to write to Mr Greenwell explaining that the Business Forum would now be overseeing the installation of the tree and lights and that they may request his assistance but to thank him on behalf of the Parish Council for all of his hard work and efforts in previous years in ensuring that on behalf of the Parish Council, Great Ayton always had a Christmas Tree on the High Green. We, on behalf of the Village we hope that Mr Greenwell will continue the Santa Sleigh Event as he has done for so many years. **Noted.** 

#### 7 Planning Report

Cllr Hudson declared an interest in planning application 16/01692/FUL.

16/01692/FUL - 5 Angrove Drive - Loft conversion, porch and rear extensions. No objections.

16/01917/FUL - 31 Angrove Close - Retrospective application for the demolition of existing dwelling and construction of new dwelling. Members raised concerns about the size of the proposed development and the over development of the site.

**16/01998/ADV - McColls Off Licence, 115 High Street** - Application for advertisement consent to display 1no non illuminated fascia sign and 1no non illuminated hanging sign. **No objections.** 

**16/01862/LBC - The Barn, Langbaurgh Farm -** Listed Building Consent for single storey extension and internal alterations to dwellinghouse (with amendments to previously approved application 15/01451/LBC). **No objections.** 

16/01915/FUL – Strawberry Fields - Construction of 10 no holiday lodges, multi-use sports pitch, recreational pond and internal road layout. Members raised the following concerns - this proposed development is outside of the LDF, this property is subject to an agricultural clause, this development would loose viable agricultural land, there is no justification for the sustainability of the site as holiday lets, the distance from the site to Great Ayton is considerable from a walking point of view, such a development is too close to ribbon development on the A172 road and creates an embryo development of a new settlement around the Tree Bridge roundabout. This development looks very similar to that at

Skutterskelfe / Rudby - this site has struggled to find occupants and very little has been developed over a considerable period of time. Concerns were also raised around the potential for this development to move from holiday lets to permanent residences.

#### 11 Councillors Reports

Cllr Mrs Greenwell raised the issue of the Boundary consultation proposals and the proposal to remove Great Ayton from the Richmond Constituency to the Thirsk and Malton Constituency. Cllr Kirk provided the following information:

- 1. Economic- Great Ayton's economy is almost exclusively based to the North of the North Yorks Moors.
- 2. There are no real links with Thirsk and Malton.
- 3. Geographic- the North Yorks Moors is a major divide between Great Ayton and the rest of Thirsk and Malton. The direct road links to the majority of Thirsk and Malton is by B and C class roads. The most direct road to Thirsk is through Richmond Constituency.
- 4. Education. The local secondary school is at Stokesley in the Richmond Constituency. Private education (albeit for a small number) is north of the North Yorks Moors.
- 5. Historical links. Great Ayton has been part of the Richmond Constituency for some 100 years and has therefore built good relationships therein.
- 6. Media communications. Great Ayton's media is:
  - Teesside Evening Gazette not Yorkshire Post.
  - Tyne Tees Television and BBC Newcastle- Leeds TV is not accessible.
  - Radio Tees Radio York is not accessible.
